## PUBLIC NOTICE

An invitation is extended to ALL SERVICE PROVIDERS (<u>Targeted Group</u>: <u>SMMEs/Emerging Businesses and Cooperatives</u>) specifically based within the GREATER KOKSTAD MUNICIPALITY to register on the Municipal Emerging Business Supplier Database. This invitation is in compliance with the Greater Kokstad Municipal Council's resolution of ensuring that it promotes inclusive radical economic transformation through its procurement processes.

The registration of local businesses on the Municipal Emerging Business Database intends to achieve a two-fold purpose:

- As a means to ensure that the budget spend of the Municipality (government) for the procurement of goods / services is targeted towards Kokstad based SMMEs / Emerging Businesses and Cooperatives through targeted/set-aside procurement and/or through 30% Sub-Contracting of relevant Capital Projects; and
- To guide the SMME / Cooperative Development Programmes of the Local Economic Unit (LED). One of the
  outcomes of this unit is to ensure that it facilitates access to opportunities, capacity building and skills transfer
  as well as possible partnerships in favour of local business development.

The database registration forms (completed in their entity) are to be returned with the following documentation:

- Original or Certified BBBEE Certificate
- Tax Pin issued by SARS on their letterhead
- Certified copies of Identity documents for all Directors or Members of the company registration document
- Proof of affiliation with Professional Bodies (CIDB, NHRBC, etc)
- Proof of locality Utility Bill (not older than 3 months) or Original Proof of Residence signed by Ward Councillor
